

AGREEMENT TO PURCHASE STAGE BANNER

Hog Capital Barbecue, Inc. agrees to sell to Buyer the following: (check only one). ✓

- 1 (one) 4 foot stage banner in the amount of \$400.00 (four hundred dollars)
- 1 (one) 8 foot stage banner in the amount of \$700.00 (seven hundred dollars)
- 1 (one) 16 foot stage banner in the amount of \$1000.00 (one thousand dollars)
- 1 (one) 32 foot stage banner in the amount of \$2000.00 (two thousand dollars)

Buyer agrees to pay Hog Capital Barbecue, Inc. the sum of _____ payable in full at the time this agreement is signed.

Fee being charged

Buyer agrees to supply any logo, artwork and text needed for the creation of Buyer's stage banner at the time this agreement is signed.

Buyer agrees that if at all possible the Buyer's stage banner will be placed in a mutually agreed on position between Seller and Buyer but said placement cannot be unconditionally guaranteed.

In return for the financial consideration being received by the Seller:

Seller agrees to provide and erect one _____ stage banner at Seller's expense for use on the Kewanee Hog Days Main Stage located in what is commonly known as the People's National Bank Lot at Third and Tremont Streets in Kewanee, IL for the 63rd annual Labor Day weekend celebration.

Banner Size/Price

Seller agrees that the banner will be erected and in full view of the general public on or before 5 PM Friday, September 1, 2017 (the opening time and date for Kewanee Hog Days) and will remain erected and in full view of the general public continuously until the Main Stage is dismantled and the Festival closes between 4 and 5 PM on Monday, September 4, 2017.

In addition, based on the stage banner size and price checked on page 1 of this agreement, the Seller also agrees to provide to the Buyer the following:

8 (eight) foot banner purchasers will be promoted 24/7 on the Seller's website: kewaneehogdays.com from June 1, 2017 or earlier until December 31, 2017 or later.

16 (sixteen) foot banner purchasers will be promoted 24/7 on the Seller's website: kewaneehogdays.com from June 1, 2017 or earlier until December 31, 2017 or later.

16 (sixteen) foot banner purchasers will also be guaranteed that no stage banners will be erected or allowed for any other business or organization that would commonly be considered a competing or similar business to the Buyer.

A 32 (thirty-two) foot banner purchaser will be promoted 24/7 on the Seller's website: kewaneehogdays.com from June 1, 2017 or earlier until December 31, 2017 or later.

A 32 (thirty-two) foot banner purchaser will also be guaranteed that no stage banners will be erected or allowed for any other business or organization that would commonly be considered a competing or similar business to the Buyer.

A 32 (thirty-two) foot banner purchaser will also be awarded title rights for the stage. All news, promotional and advertising activities (print, audio, video or web) that refer to the Main Stage will refer to it by that business or organization's name. (Example: Appearing Saturday on the First Financial Stage at 7:30 PM will be the Sting Rays etc... or free entertainment all Hog Days weekend long on the ABC Manufacturing Stage etc...
