RULES, REGULATIONS AND REOUIREMENTS

- 1. Concessions are to be set-up in assigned locations in the downtown area of Kewanee, IL.
- 2. Space size is 10-foot frontage with a price of \$250.00 per space. NO SPACE DEEPER THAN 12 FOOT
- 3. All spaces are leased to concessionaires for the entire length of the festival only.
- 4. Hog Capital Barbecue, Inc. <u>reserves the right to LIMIT types and/or REJECT any concessions.</u> Concessionaires may not sell butterfly pork chops or pork patties in any form. Roasted (not cooked on a charcoal or gas grill) pork or breaded pork tenderloins can be sold. Each concessionaire may only sell those items listed and approved by the concessions manager. Specialty items will be limited so it is important to return your contract as soon as possible.
- 5. No hawking, amplification of voice, or any other devices, human or mechanical, which may be deemed annoying to other concessionaires, is permitted.
- 6. <u>All booths must be serviced before 10:00 a.m.</u> No vehicles will be allowed in the concession area after 10:00 a.m. and before 9:00 P.M.
- 7. The concession area is open to all concessionaires both for profit and not-for-profit.
- 8. All concessions will be set up at the Concession Manager's discretion.
- 9. Booth set up will begin at <u>5:00 PM THURSDAY NIGHT!</u> You will not be allowed to open on Thursday Night, this is set up only. Booths are to open at 5:00 P.M. on Friday night. Concessions must be manned and opened by 11:00 a.m. each morning thereafter, and must be open until at least 9:00 P.M. Friday, Saturday and Sunday and until 5:00 P.M. on Monday.
- 10. Security is provided at the site of the Hog Capital Festival 24 hours each day of the festival.
- 11. Concessionaires must supply all of their own extension cords with at least 50 feet of such electrical extension cord. Please supply maximum amperage that will be needed on the contract (page three of this document).
- 12. Limited water hookups are available. Be prepared to hook in with another concessionaire. Concessionaires must supply at least 50 feet of their own hoses.
- 13. Each concession shall be self-contained with <u>NO DRAINAGE ON THE STREET.</u> There are gray water dump stations spaced throughout the concession area. Concessionaires are responsible for keeping their respective areas looking clean. All trash should be bagged and tied and placed in front of their booth at the close of the day. Grease dumping service is available. Ask the concessions manager for details.
- 14. The entire cost of the leased space, which is \$250.00, must be paid in full (money in our hands) on or before August 16, 2025. If any spaces are still available after August 16, 2025, space will be leased on a first received/first approved contract basis.

RULES, REGULATIONS AND REOUIREMENTS CONTINUED

- 15. Rates Payable to HOG CAPITAL BARBECUE, INC.
 - a. On or before August 16, 2025 \$250.00 per space (10 feet frontage x 12 feet deep)
 - b. After August 16, 2025 a 20 percent \$\$ surcharge will be added to the total space being leased.
 - c. Additional space is \$100.00 for each 5 feet. Please be certain to include the tongue and hitch of your trailer in your footage measurements.
 - d. A flat \$75.00 fee will be added for electrical.
- 16. <u>SPECIAL NOTE: Do not short yourself on space (INCLUDE RIG TONGUE & AWNINGS IN YOUR SPACE MEASUREMENTS)</u> because if the space is not big enough, you will be moved to whatever space might be available. If it is not satisfactory and you leave, there will be no refunds.
- 17. Hog Capital Barbecue, Inc. *MUST* be provided with a certificate of insurance.
- 18. Hog Capital Barbecue, Inc. *IS NOT* responsible for lost or stolen property and *IS NOT* responsible for any accident or illness.
- 19. ALL CONCESSIONS MUST POST PRICES IN PLAIN VIEW.
